



## Health Guarantee & Purchase Agreement

Thank you for choosing The Woof Gang to welcome your new puppy into your home. A \$500 non-refundable deposit is required to reserve a puppy and will be deducted from the final purchase price. The puppy must be paid in full, including any applicable shipping fees, prior to pickup or delivery. To activate the one (1) year genetic health guarantee, the purchaser must have the puppy examined by a licensed veterinarian within seven (7) days of pickup or delivery and provide documentation of that exam; failure to do so voids the guarantee. This guarantee covers serious genetic disorders diagnosed within twelve (12) months and confirmed in writing by two licensed veterinarians, one of whom may be selected by the breeder. If confirmed, The Woof Gang will either replace the puppy with one of equal value when available or refund the purchase price minus shipping and veterinary expenses, provided the puppy is returned to us; transportation and testing expenses are the responsibility of the purchaser. The puppy is also guaranteed against life-threatening viral diseases including Parvovirus and Distemper for seven (7) days after pickup or delivery with proper veterinary documentation; the puppy may not be euthanized without breeder consent unless medically necessary and documented, and replacement is the sole remedy under this provision. Parasites including Giardia, Coccidia, worms, fleas, ticks, mites, kennel cough, and other minor or treatable conditions are not covered, as these are common and may result from environmental exposure. The purchaser assumes all medical expenses after pickup or delivery and agrees to provide proper nutrition, vaccinations, deworming, veterinary care, exercise, shelter, fresh water, and social interaction; any signs of neglect or abuse void this agreement. The Woof Gang does not guarantee adult size, weight, conformation, or temperament. The puppy may not be surrendered to a shelter, rescue, or third party without breeder approval, and if the purchaser is unable to continue care, the puppy must be returned to The Woof Gang with no refund or compensation required unless otherwise agreed in writing. This contract is non-transferable and governed by the laws of Marshall County, Indiana, where any legal proceedings shall take place, and any legal fees incurred will be the responsibility of the purchaser.
